



Policy Document on Award of Scholarships and Freeships

One of the most valuable and expensive assets in today's society is education. In order to pursue a vocation that needs many years of college, the majority of high school graduates ask for financial aid. Scholarships emerge as the most requested type of financial aid in such a situation. This is due to the fact that scholarships are not repaid, in contrast to student loans.

The college has a policy that prohibits any student who is admitted on the basis of merit from quitting school due to financial difficulties. In light of this, the institution has put in place measures to assist those students who require financial or material support for their education. The college selects candidates purely based on their merit.

Other Scholarship Availed by Students

E-Grants

The Government of Kerala created the e-Grants Scholarship Portal, a centralized online grants disbursal mechanism. Residents of Kerala who belong to economically disadvantaged groups like SC, ST, OBC, and minority groups are eligible to apply and receive the e-Grants scholarship amount. The e-Grants site enables the institution to apply for the scholarship on behalf of the students if they are unable to do so themselves. After being admitted to a course, interested students have one week to submit their applications.




Post-Metric Minority Scholarship

Ministry of Minority Affairs (MOMA) offers post-metric scholarships for minorities in order to support students from underrepresented groups. The following groups have been designated as minority communities by the Indian government: Muslims, Sikhs, Christians, Buddhists, Zoroastrians (Parsis), and Jains. Students in class II through PhD are eligible for up to INR 10,000 in annual scholarships under this post-matric scholarship programme for minorities.

Post-Metric-Central Sector

The Department of Higher Education of MHRD created the Central Sector Scholarship Scheme for College and University Students, a centrally-funded merit-plus-means scholarship. The Central Sector Scholarship Programme, which was established with the goal of aiding students from economically disadvantaged families, awards grant to a total of 82,000 graduate and postgraduate students each year. This scholarship is distributed equally to boys and girls, with 41,000 of the total awards going to male applicants and the remaining 41,000 to female applicants. A scholarship award of up to INR 20,000 is given to the chosen students each year to help them cover their living expenses while pursuing higher education.
