The candidate should submit progress reports in the prescribed form [Appendix IV of the Ph.D. Regulations] ONCE IN SIX MONTHS and the same be placed in the Doctoral Committee and send it to the Dean – Academic Research through the Supervisor. The RAC Meetings should be conducted in VISTAS Campus.

The candidate will be governed by the Rules and Regulation of the Ph.D. Degree framed there under and amended from time to time.

ORDER:

In the letter first read above for **Mr. Anish B Bhaskaran**, has been permitted to register Provisionally for Ph.D. Program in Commerce on **Part-Time** basis from **25.09.2020** under the guideship of Dr.K.Manikandan, Assistant Professor, Department of Commerce, School of Management Studies and Commerce, VISTAS, Pallavaram, Chennai- 600 117. In the letter second read above, the Research Supervisor has sent a Panel of four members so as to nominate two subject experts by the University to constitute a three member Doctoral Committee with the Research Supervisor being the Convener.

Examining the above Panel in detail, orders, constituting a Doctoral Committee are issued in respect of above Research Scholar provisionally registered for the Ph.D. degree as follows:

1. Dr.K.Manikandan, Assistant Professor, Department of Commerce, School of Management Studies and Commerce, VISTAS, Pallavaram, Chennai- 600 117. (Convener)
2. Dr. A. Krishnan, Associate Professor, PG & Research, Department of Commerce The Presidency College, (Member)
3. Dr. K. Selvasundaram, Associate Professor & Head, Department of Commerce, Faculty of Science and Humanities, (Member)

The functions of the Doctoral Committee are as follows:

1. To discuss advice and recommend on all matters connected with the student's research from provisional registration till the submission of thesis. (Convener)
2. To suggest courses to be undertaken by the student during the first year of provisional registration in the light of attainment and with a view of fulfilling the requirements of the research.
3. To examine the student through written and oral examinations, on the completion of such courses, at the end of the first year of provisional registration and to report to the University on the fitness or otherwise of the student to proceed with his/her research work for the Ph.D. Degree and recommending the confirmation of the provisional registration.
4. In case where a student is not approved at the end of the first year by the Doctoral Committee, it may recommend that the candidate should undergo additional course for a further period of not exceeding 6 months, at the end of which he/she shall be examined again; and if found fit, his/her provisional registration will be confirmed and he / she will be permitted to proceed with his/her research work.
