This is an agreement between "Party A", hereinafter called CHASS and "Party B", hereinafter called Department of Corporate Economics, SCAS

I. PURPOSE & SCOPE

The purpose of this MOU is to clearly identify the roles and responsibilities of each party as they relate to increase the social responsibility of both the organizations. II. BACKGROUND

The party A is a charitable organization owned by the Catholic Archdiocese of Changanassery having its office in Changanassery and registered under the Travancore Cochin Charitable Societies Act, 1955.

The party B is an Arts and Science College and is a Christian minority institution affiliated to Mahatma Gandhi University which is owned by Mar Gregorios Educational Society. This college was established in 2004 which aims at the holistic development of the youth.

III. [PARTY A] RESPONSIBILITIES UNDER THIS MOU

[Party A] shall undertake the following activities:

It trains the youth in the fight against social evils such as drug abuse, organizing seminars and symposia for the integrated development of the college students.

Party A will also give opportunities to the students of Party B for conducting academic project work related to the activities of CHASS, visit the offices of CHASS and interview the stakeholders of CHASS.
