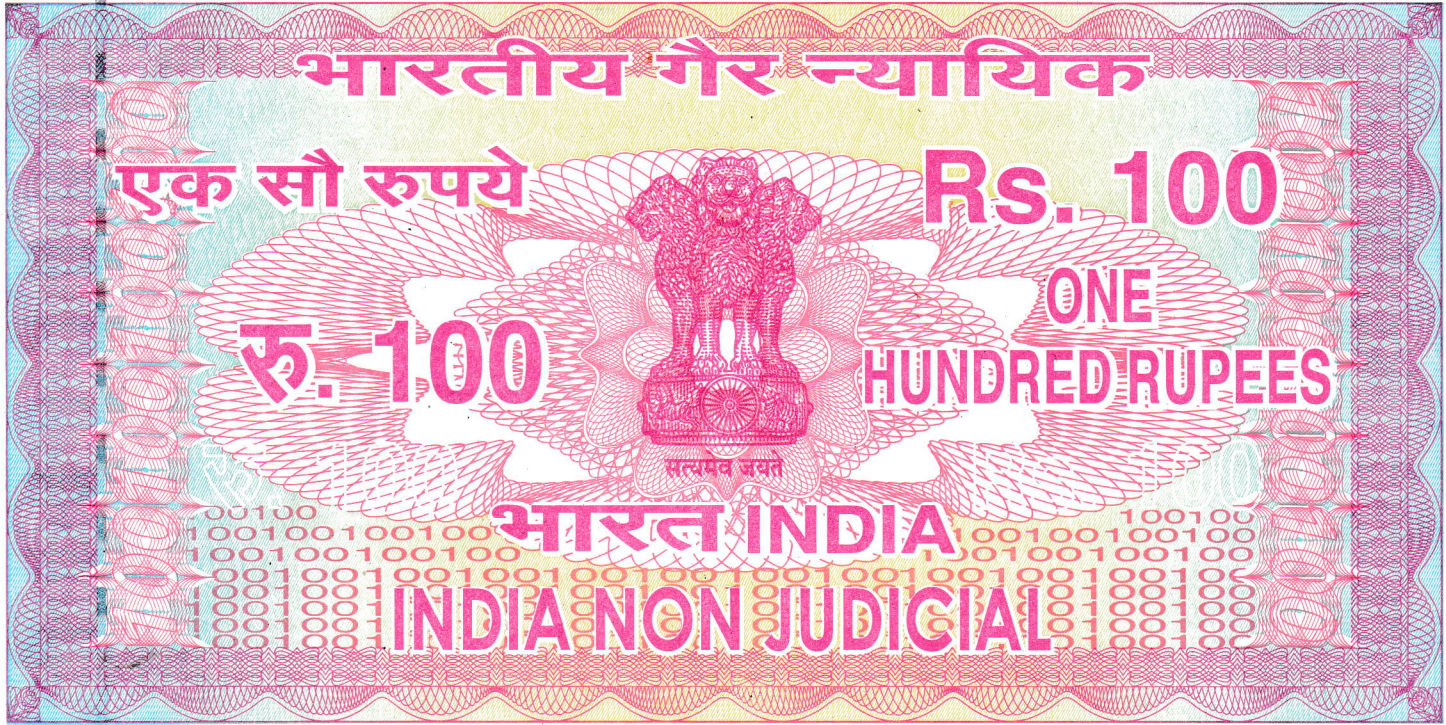

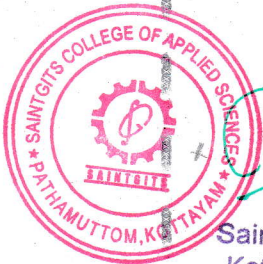

AND WHEREAS both the parties have, in principle, accepted the terms and conditions mutually agreed upon by and between them

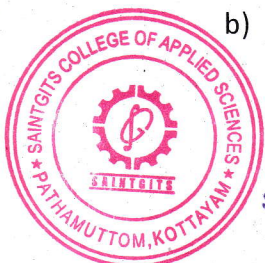
AND WHEREAS the parties hereto are desirous of recording the said terms and conditions in the manner hereinafter appearing:

- c) Conducting internship programmes for the students of SCAS.
- d) Conducting programs of variety of nature for capacity building
- e) Any other event in tune with capacity building in commerce and education

#### **Conduct of various programs, events, Seminars etc.**

- (1) The said courses / programs/ events called by any name shall be conducted by the SCAS and M/s Purackal Honda in collaboration and shall be overseen by a Standing Committee consisting of one representative each of SCAS and M/s Purackal Honda and advised by Heads of Institutions of SCAS and M/s Purackal Honda.
- (2) The venue (online / offline) of the said courses, programs, events called by any name shall be decided and conducted by mutual understanding of both the parties
- (3) The content and the delivery of the course / program shall be designed by mutual understanding by both the parties.

#### **Goodwill:**

SCAS and M/S Purackal Honda both shall endeavour to maintain, promote and improve the goodwill and image of both the organisations.

#### **Tenure:**

This Memorandum of Understanding shall continue to be in operation for a period of two years commencing from the date of signing this MoU. Upon the expiry of this Memorandum of Understanding and/or six months prior thereto, both parties are entitled to the renewal of the Memorandum of Understanding for a future period of two years by issuing a written notice to the other to that effect.

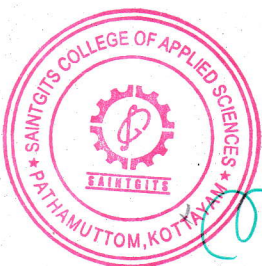
#### **Termination**

- (1) If there is a breach of any of the conditions by either party then the Memorandum of Understanding may be terminated with one-month notice by either party without affecting the students' or participants' larger interest.
- (2) The Memorandum of Understanding may be terminated with three months' notice by either side or by mutual consent.

#### **On Termination:**

On termination of this Memorandum of Understanding:

- (a) No fresh joint, collaborative programmes, called by any name, shall be undertaken by either of the institutions thereafter.

- (b) Neither parties shall not be responsible for any loss or damage which may be caused because of destruction of any materials, cancellation of any programmes or in any other manner or on account of termination of this Memorandum of Understanding.
- (c) Parties hereto agree to settle outstanding dues, if any.
- (d) Neither SCAS nor M/S Purackal Honda shall have any right or title or interest in the name and goodwill of the other party
- (e) None of the parties shall, after termination of the Memorandum of Understanding, claim, advertise or suggest any association with another party.
- (f) Legitimate interests of students, participants will be protected, within two year of discontinuation of the Memorandum of Understanding as applicable or the culmination of the last joint programme commenced before the discontinuation.

#### Third party Agencies:

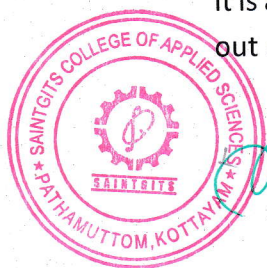

#### Force Majeure:

Neither party to the Memorandum of Understanding shall be liable to the other party for any delay or failure on its part to performing any of its obligations under this Memorandum of Understanding resulting from any cause beyond its reasonable control, including, but not limited to strikes, riots, civil commotion or other concerted action of workmen, material, shortage, fire, flood, explosions, acts of God, acts of State; war, enemy action or terrorist action.

#### Arbitration:

It is agreed by both the parties that in the eventuality of any disputes or differences arising out of or in connection with or arising out of this Memorandum of Understanding or in
