Report

The Department conducted a National Level Online Quiz programme for the World Environment Day on 5 June 2021. It is the United Nation's principal vehicle for encouraging awareness and action for the protection of the environment. The competition was open to the students of other colleges and also for Saintgits College of Applied Sciences. A total of 224 registrations were received for the event. A whatsapp group was created to pass the necessary instructions to all the participants. Registrations were received from six states namely Karnataka, Tamil Nadu, Andhra Pradesh, Assam, Rajasthan and Kerala. Twenty-five multiple choice questions were prepared for the quiz and the participants could attempt the quiz from 10 am to 5pm. 158 participants were awarded certificates for scoring 70 percent and above. Twenty students scored 90 percent and above and were also given special appreciation certificate.

The third year students (batch of 2019-22) also created a video highlighting the ill-effects of human activities on our environment and solutions to preserve the environment. The video also paid tribute to Sunderlal Bahuguna (9 January 1927 – 21 May 2021), who was the leader of the Chipko Movement (1973).

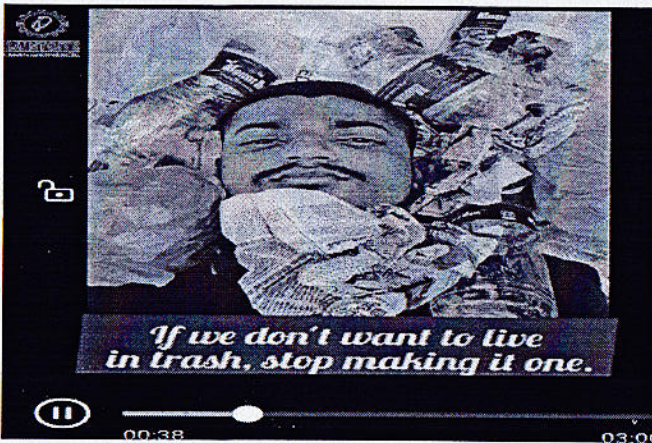
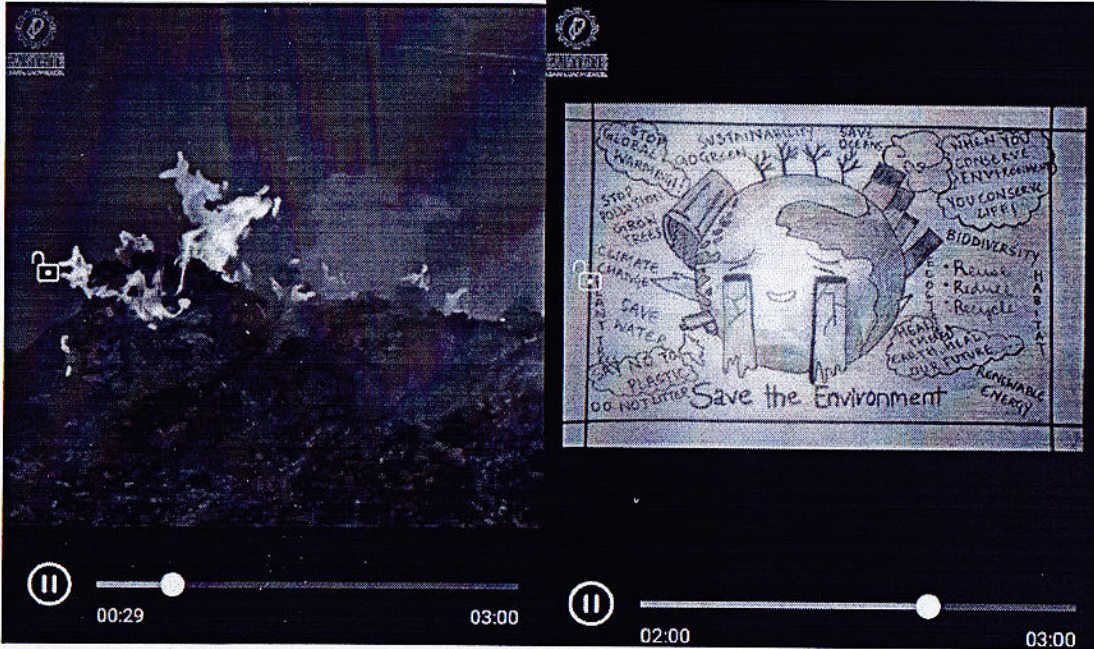

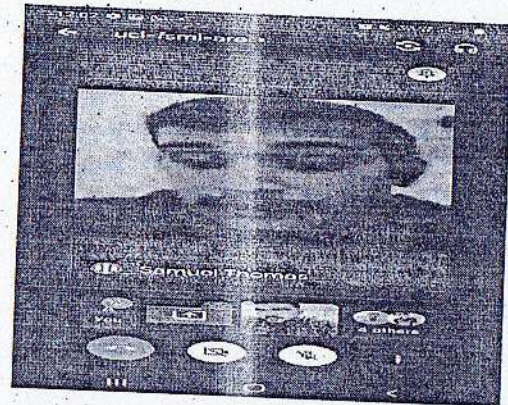
