

Action taken by affiliating university on feedback

- As per the suggestion put forward by stakeholders, the university has taken utmost care to ensure that there is no delay in getting results published after reevaluation, especially in the final year and hence students are able to pursue higher studies without any difficulties.
- Faculty development programs on outcome based education were conducted for teachers taking into consideration the suggestion put forward by us.
- In the light of the suggestion, to introduce MOOC courses to fill curriculum gaps, a MOOC course on Organic farming was introduced for all undergraduate programmes.
- During the covid period, many of the students represented a concern that that if examinations are conducted in the regular pattern, they would not be able to write the entire answers. Hence the university adopted a liberal pattern of examination in this context.
