MEMORANDUM OF UNDERSTANDING

Between

SAINTGITS COLLEGE OF APPLIED SCIENCES

PG DEPARTMENT OF COMPUTER APPLICATIONS AND ARTIFICIAL INTELLIGENCE,

And

Government U P SCHOOL, PATHAMUTTOM, KOTTAYAM

This agreement is made between the PG Department of Computer Applications and Artificial Intelligence, Saintgits College of Applied Sciences, Pathamuttom, Kottayam hereinafter called "Party A" and Government U P School, Pathamuttom P.O., Kottayam - 686532, hereinafter called "Party B".

1: BACKGROUND

The party A is an Arts and Science College and a Christian minority institution affiliated to Mahatma Gandhi University, Kottayam, owned and managed by Mar Gregorios Educational Society and approved by UGC under Section 2(f). This college established in 2004 aims at the holistic development of the youth with societal concern.

The party B is a Government U P School at Pathamuttom, Kottayam.

2: TERM & SCOPE

The purpose of this MOU is to enrich the students of the Government U P School, Pathamuttom, by providing technical sessions and equipping them with the lab facilities in the college, under the extension activity organised by the PG Department of Computer Applications and Artificial Intelligence, Saintgits College of Applied Sciences, Pathamuttom, Kottayam.

Party A will provide members of their faculty and students to Party B to offer trainers' assistance for the courses introduced by Party A. Also, Party A will provide the lab facility for the students of party B. Party B can utilise the lab facilities provided by Party A for 4 hours on a month.

The department will handle the topics that is mutually agreed upon by both the parties. Party B will ensure that the faculty assistance provided by Party A is utilized and managed efficiently.

The term of this agreement is for a period of one year from the date of signing of this MOU and it can be extended further by writing between the parties.

In addition, Party A shall provide training material by joint agreement for exclusive use by Party B that will not be used, copied or transferred by any other educational institutions and Party B shall decide the modalities of training as mutually agreed.

Objective

The objective of this program is to provide the school students with theoretical as well practical exposure on various areas given in the syllabus.

3: CONVENANTS

Party A shall provide all training materials to Party B. Party A will conduct follow-up programs for the students periodically and provide them required inputs so as to upgrade their skills and update them on the developments in the areas of the aforesaid courses.

Party A will be responsible for providing the

- > The trainer
- > Training content (Including Theory & Lab)
- > Assessments

4: INTELLECTUAL PROPERTY RIGHTS

Neither Party B nor Party A shall use at any time, whether during the currency of this Agreement or thereafter, or exercise any lien in any manner whatsoever, over the trade name or any other trademark or domain name or copyrights of the other party, except wherever mutually agreed in writing.

Neither Party A nor Party B will divulge any technical information, official data, training records, database, training literature and course module or any other relevant information pertaining to one or either of the parties to any third parties without the prior written consent of the former and later.

Neither the party nor their employees will use the technical training materials of the other party without the knowledge and prior written permission of the other party to run any program, forum, conference or seminar.

5: LEGAL STATUS OF THE PARTIES

This Agreement shall not be construed as a partnership or agency between the parties and neither party shall have an authority or power to bind the other or to contract in the name of the other and create any inability against the other in any way or any purpose.

6: TERMINATION

Either party can terminate this agreement without assigning any reasons after one week notice in writing to the other party.
