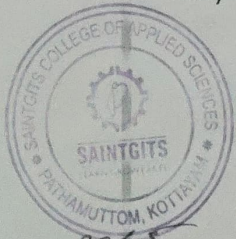

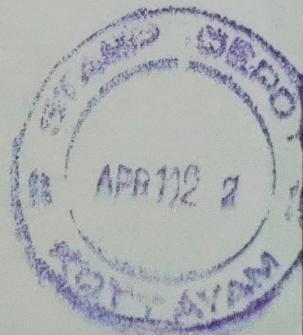

1. BACKGROUND



3. PROGRAM DURATION AND MATERIALS


5. LEGAL STATUS OF THE PARTIES


